

The EU-related journals from Polish perspective. An overview based on the holdings of the Library of the College of Europe Natolin.

1 College of Europe

1.1 History

The College of Europe's creation goes back to the 1948 Hague Congress. Salvador de Madariaga, a Spanish Statesman, thinker and writer in exile, pursued the idea of establishing a College where university graduates from different countries could study and live together.

A group of Bruges citizens led by the Reverend Father Karel Verleye were successful in attracting the College to Bruges as part of their efforts to restore its European renown. Professor Henri Brugmans, one of the intellectual leaders of the European Movement at the time, became the first Rector of the College of Europe (1950-1972) and decisively shaped its development and what is known as the "esprit de Bruges". Since 1949, students and professors of fifty Promotions - as College academic years are known, each one named after an outstanding European - have contributed to the development of the Europe we see today.

Since the very beginning, the academic programme has offered courses which closely follow the move towards European integration. It has continuously adapted its programmes, insisting on high quality and standards so that graduates of the College would be equipped to meet the challenges of their times. The College is characterized by its independence, its bilingualism (English and French), the diversity of its teaching staff (academics and practitioners across a wide variety of fields) and its multicultural environment creating a real "European microcosm".

In response to the challenge posed by the opening of Central and Eastern Europe, the College founded a second campus in Natolin (Warsaw) in 1994 at the invitation of the Polish government. On the basis of a trilateral agreement signed by the College of Europe, Poland and the European Commission, the formula of "one College - two campuses" will be implemented from 1999 onwards. The College moves into the new

Millenium ready and able to face the challenges involved in building a new and wider Europe.¹

1.2 Organization.

The College of Europe, an independent academic institution, is based on two campuses and is managed through institutional structures which aim to promote both academic and practical approaches to European integration issues. With its two campuses the College is able to carry out its mission throughout the whole of Europe.

The primary mission of the College of Europe, which is education and practical training in European affairs at a high level, is overseen by the Academic Council, drawn from members of the College academic community.

Rector Otto von der Gablentz directs and coordinates all the College's activities. In close cooperation with him, Vice-Rector Piotr Nowina-Konopka is responsible for the direction of the College of Europe campus at Natolin

1.3 Teaching staff & student's profile.

The College attracts specialists from a wide range of academic and professional backgrounds from all over the continent to form its teaching staff. Students are therefore provided with teaching standards of the highest quality and they benefit from an enriching diversity of approaches. In Bruges and in Natolin, assistants - Alumni of the College - supervise the work of those currently studying and ensure good working relationships between teaching staff and students. The student body, currently 270 in Bruges and 90 in Natolin², also reflects the diversity of culture and personal experience on our continent. Across both campuses the students, whose average age is 25, come from over 30 different countries and usually speak three to four languages. They have all completed a university degree in a field appropriate for participation in the College's postgraduate programme. The subjects range from law and economics to political sciences and the development of European society.

1.4 Academic Programme.

The College of Europe - Natolin programme also combines an interdisciplinary approach (first semester) with the opportunity for each student to specialize. It focuses both on European integration and the transformation processes taking place in Central and Eastern European countries. The academic year begins with a three-week intensive introduction to European law, economics, history and institutions (the "pre-stage"). The first semester consists of compulsory courses that provide students with an overview of the fundamental aspects of European integration, the region's history and geopolitics, and the relations between the European Union and Central and Eastern Europe. The second semester is divided into six "dominantes": Law,

Economics, Politics and Administration, Dynamics of pre-accession, European Union systems and European Foreign Affairs. Students enrol in one of the "dominantes" in which they follow a set number of courses. To qualify for the "Master of European Studies" degree, students must pass examinations in their chosen subjects and submit a Master's paper.³

1.5 Libraries.

The libraries of the College of Europe are renowned for the wealth of their information resources on European affairs. The main fields covered are law, economics, political and administrative sciences, human resources development, contemporary history and sociology, with a particular emphasis in Natolin on EU enlargement and transition issues in the countries of Central and Eastern Europe. Both libraries also host European documentation centres containing official publications - increasingly in electronic form - of the European Union, the Council of Europe, the OECD and other international organizations. A high priority is placed on the development of easy access to fast-growing electronic information resources and multimedia facilities, with on-line access to the library catalogues and to networked CD-ROMs, as well as access to document delivery services and electronic information resources worldwide. Both Bruges and Natolin provide computerrooms offering full scale Internet and e-mail services to students.

2 Natolin Library.

The Library of the College of Europe in Natolin was established in April 1993 and in its original form it consisted of a collection of approximately 300 books. Thorough initial consultations with the users and the Bruges Library then led to the establishment of the central core of the Periodicals Department collection (in the initial stage of the Library activity it was approx. 70 periodicals). At the same time the Natolin Library was granted the double status of European Documentation Centre (EDC) by DG X of the European Commission, for both French and English language versions of the documentation.

The function of the Library consists of gathering, describing, managing and granting access to the Library resources and academic materials in the form of different types of publications necessary for the academic programme of the College as well as in carrying out a user-oriented information activity. The Library in Natolin also serves the outside readers, answering to numerous queries and leading various research activities.

The intensity of a ten-month long academic programme of the College of Europe Natolin requires that the services rendered to students considerably exceed the "traditional" activity, apart from which the Library manages a separate book collection prepared on the basis of reading materials obligatory for each course individually (the

so called “professors’ reserves”) and delivers documents directly to users. The latter is the case when the Library is able to get a given document, usually an EU legal act or an article from a journal, in electronic form. An inter-library exchange with the Library of the College of Europe in Bruges has been also arranged, which allows to use the Bruges collection by Natolin students.

At the beginning of every academic year the Library organises an Information Seminar on the topics of EU information policy and the sources of European information. During 15 hours of lectures and workshops students have the possibility to discover the practical outcome of the decision-making procedures of EU institutions in the physical form of various sorts of documents and get acquainted with the structure of the Library collection during detailed guided tours. A training in how to use the Library catalogues, the resources of local databases as well as the information and legal services on the Internet is also an important element of the seminar.

During the second semester the information distribution is led in a more selective and personalised way. It consists in current and retrospective review of materials gathered in the Library, oriented towards the topics selected for the master theses. The students are kept informed about new acquisitions (mainly books) connected with the subject of their interest.

The Library team is also responsible for collecting case law for the courses during which the use of such documents is necessary. As far as the courses on competition policy, the free movement of goods, persons, services and capital are concerned, the relevant case law has been made available in the form of intranet pages, accessible 24h a day, which has been an important improvement for the users. There also exists the possibility of receiving the set of materials by e-mail. The general rule of the information activity of the Library of the College of Europe Natolin is to ease the students their tasks by delegating to the Library staff the burden of researching and collecting the materials required by the academic programme.

The Library is open 68 hours per week, 12 hours from Monday to Friday and 8 hours on Saturdays. The premises of the Library are located on two levels of a building of historical monument status, a nearly hundred-year old royal stable which is a part of the palace-and-park complex of Natolin. In the Library there are two reading rooms and two computer rooms, one of which is provided with the equipment necessary for the multimedia use.

The Library employs 6 librarians responsible for cataloguing, indexing and managing the collection. Everyone has his turn of duty at the loan desk and this solution ensures a direct contact between the user and the librarian responsible for every particular part of the collection and therefore a better communication and flow of information concerning the materials gathered in the Library.

The Library put at the disposal of the students 23 computer posts equipped with PentiumII processors, 17 of which are available in the computer rooms open 24h a day, 7 days a week. This also comprises the possibility of printing on high-speed network laser or colour printers and a free access to photocopying machines and scanner. All computer posts are connected to the Internet and the intranet

environment of the College and the users are granted individual access accounts to the system and electronic mail. The Library of the College of Europe Natolin uses an optical cable link of 2 Mb/s and a guaranteed speed of data transmission of 512 kb/s. The users may also access the library catalogues and local databases from any computer within the premises of the College, and the owners of private PCs (or laptops) are able to use the whole teleinformatic infrastructure from any spot in the College, included their own room.

The Library of the College also owns a microfiche reader used to produce copies from the EU Official Journal archive from the period of 1960-1990.

Due to space constraints connected with the need to adapt the old stable buildings to the Library requirements, the books are stored on compact sliding shelves assuring the possibility to store a great number of volumes in a limited space. The Periodicals Department is an exception, as here the collection is kept in specialised furniture system consisting of book-cases with plastic display cassettes, which allow to store the bound volumes inside the boxes and at the same time to exhibit the most recently published issue.

2.1 Library organisation

The Library of the College of Europe Natolin is divided in three main departments: Books Department, Periodicals Department and the European Documentation Centre (EDC).

2.1.1 Books Department

This department is a collection of approximately 10.500 monographs (mid 2000). All users have free access to them during the Library working hours. They are arranged in aisles of mobile shelves in a ground floor.

2.1.2 Periodicals Department

The Periodicals Department gathers more than 300 titles of the most appreciated journals dealing with the subjects taught in the course of studies in Natolin. It is divided in four sections:

1. journals main collection
2. working papers
3. European matters and
4. daily newspapers.

A unique possibility offered by the Library is its system of article cataloguing. All the articles from every arriving journal (or working paper) are entered into database and classified by key words according to the French version of EUROVOC Thesaurus.

The journals themselves are arranged in sections concerning respectively the European Communities and European Union, East-Central Europe, international relations, economy and others (human rights, security and defence, sociology, history, geopolitics, culture). The journals and working papers are exposed on the front of their boxes.

Natolin Library contains a large collection of working papers of several institutions including such well known international organizations like OECD or WEU as well as academic or independent research instituts and centres active in areas of European affairs, economy, international relations and political sciences.

Working paper (in French 'documents du travail') is a special kind of information source. As the Dictionary of Archive and Library Terminology defines - it is a preparatory document such as draft, sketch, project, report used in preparing a book or an article, and published to provide the information concerning current research projects of the author or the institution and to stimulate discussion about the problem, thus working papers are often called research papers or discussion papers.

The principal feature of titles published as working papers is that they deal with the short-term economic, legal or political trends and problems. Working papers appear irregularly and have usually continuous numbering.

2.1.3 The European Documentation Centre.

The EDC, according to the rules that every such centre must obey, has its own separate room. The Natolin EDC gathers wide resources of documents and publications concerning the European Union from the Community institutions. The materials and documents are published and distributed by the Office for Official Publications for European Communities (OOPEC) in Luxembourg.

The EDC is divided into 17 divisions / sections and these are divided into subdivisions. The first division contains also the documents of the European Institutions as well as of the UNICE. All the resources are divided into monographs, periodicals and documents.

For the time being (mid 2000) Natolin EDC has a collection of 3100 monographs. It increases steadily as every year we receive some 600 new publications. The monographs and periodicals have their signatures, which indicate the division the publication belongs to, on the right top corner. The monographs are registered in the inventory book and also entered into a computer database. In this catalogue the publications can be searched through Indexes by the institution that produced it, its title, the keywords (EUROVOC thesaurus), etc. Monographs are arranged on the shelves by signatures and not by accession numbers. The third group of publications are the documents, and the most important among them is the Official Journal.

The Official Journal is the major source of information on EU legislation and activities. It is published every day in all the Community official languages. It is divided into three series: L, C and S and Annex of Parliamentary Debates. L series (Legislation)

contains the texts of the Treaties, amendments to Treaties, Regulations, Directives, Decisions, etc. C series (Information and Notices) acts as an official “board of information” for ex. CA series informs about the vacancies in the European Institutions. S series (Supplement) informs about the public offers (only CD-ROM version is available). Natolin EDC contains paper versions of L and C series from 1987 in English and 1993 in French as well as microfiches: L and C series in French and English, from the beginning till 1993.

In order to learn more about the official documents of the European Union please use one of the best monographs available - Guide to Official Information of the European Union (3rd edition) by Veerle Deckmyn from European Institute of Public Administration.

2.2 Access to the Library for the external users

The access to the collection of the Library of the College of Europe Natolin for outside visitors is possible after obtaining the permission of the Library Director. The number of such permissions granted is subject to limits due to the requirements of the primary objective of the Library, which is the service to the students of the College, and equipment, room and staff capacities. At the same time, the profile of the Library collection is basically designed to serve the needs of the academic programme of the College and therefore, in many cases, the Library is not able to meet the requirements of outside users searching for their particular topics. The Library of the College maintains contacts with other EU information centres and specialised libraries, so that those users can be advised where to turn to for what they are interested in. Nevertheless there are approximately 200 visits of outside users per year received, and twice as many queries answered.

3 Selected EU-related journals from the Library collection

3.1 Specialised daily and weekly newspapers

3.1.1 Europe Daily Bulletin.

Founded in 1952, Agence Europe is the oldest international press agency providing current awareness services on European Union economic and political developments and European integration. The most known publication of Agence is released five times a week (except Sunday and Monday) *Europe Daily Bulletin*, which provides detailed news and analysis of developments in the EU.⁴ *Europe Daily Bulletin* includes a weekly statistical supplement (*Selected Statistics*), weekly overview of recently published documents and books (*European Library*) and publishes in *Documents* series the most important official EU documents such as presidency conclusions, declarations and other key documents.

Europe Daily Bulletin is available in four languages: in French, English, Italian and German in a printed version. In addition, the electronic version of the *Bulletin* called *DanteNet* allows to download and store on the personal computer up to 10 latest bulletins. In order to use *DanteNet* application the user must download the special software through the Internet, proceed the installation and enter a password. From that moment, every morning from 8 a.m. Brussels time, the user may open the *DanteNet* application and download of the latest *Europe Daily Bulletin*. The operation is wholly automatic and takes only a few seconds.

DanteNet software was introduced in the beginning of the year 2000 as a logical extension of former electronic supplement called Dante. The principle remains the same as the user may download the bulletin daily, but the advantage of Internet platform reduces the cost of daily modem connection with Brussels and possibility of storage and access up to 10 latest bulletins avoids the potential gaps (Dante software disallowed the download of the the previously published issues giving access only to the current one).

The user may obviously consult the bulletins on the screen, print them in their entirety, or in part, and use the copy/paste function; a key word search reduced to only one issue of the bulletin is also available.⁵ The table of contents of the current *Bulletin* is available on the daily basis on the publisher's website at <http://www.agenceeurope.com>.

Europe Daily Bulletin is also available as an archive on CD-ROM and contains the complete text of bulletin from January 1995 until now, plus the history of the ECU / EURO currency as well as *European Library* and full *Europe Documents* series. The search engine allows to browse the documents on themes, subjects, words of the text, words of the title, etc, or combine multiple conditions using Boolean operators. The found documents can be easily displayed, printed, annotated or exported to an text file.

Interesting discounts up to almost 50% for academic libraries are available.

It offers an analytic, detailed and complete view on accession negotiations between the EU and candidate countries, bilateral relations between the EU and all the other countries of Europe and the Commonwealth of Independent States (CIS).

Three main sections of the bulletin are:

- EU accession
- Bilateral relations with the EU
- Trade and finance.

and cover the political, economic, commercial, financial, cultural and scientific relations between the EU and the candidate countries.

Uniting Europe Document section which appears irregular contains the most important key documents and statistics related to the process of enlargement of the EU.

European Report appears twice-weekly and contains the regular and comprehensive overview of EU affairs covering the activities of all institutions such as European Parliament, Council, Commission and Court of Justice, etc. The bulletin contains also the weekly listing of the most important legislative documents and proposals taken from the Official Journal of the European Communities, informations about the conferences and new publications as well as the European diary which covers the main activities of the EU institutions and its officials.

Main sections of the *European Report* are:

- European institutions
- Economic and monetary affairs
- Business brief
- Internal market
- External relations

European Report has two printed supplements: weekly *International Business News* which covers mainly issues and current informations from the commercial and business environment including the takeovers, and the irregular supplement called *Document* containing EU official documents such as European Parliament plenary session documentation or Presidency Conclusions of European Council meetings.

European Report exists also in the electronic format. EIS publishes quarterly updated CD-ROM which contains the full text version of the printed *Report*; research could be conducted by keywords, dates and publication references. The price of this product is very low while the subscription to the printed version is active.⁶

EIS provides also on-line version of *European Report* within the service Net Delivery which is complementary to, and dependant on subscription to the hardcopy version of the bulletin. While the hardcopy version is being printed, an electronic version of the publication is issued on the Internet. This electronic version of *European Report* is available at 19.30 Brussels time on the eve of the publication date whereas all other bulletins published by EIS are released in the afternoon of the publication date. In other words, Net Delivery allows subscribers to receive an electronic PDF file before the reception of the printed version some 3-5 days in advance (case of Warsaw). Net Delivery service is free of charge, this service is included in the price rate of hardcopy subscription.

European Report is reproduced in extenso in commercial information services such as Reuter's EU Briefing⁷, Lexis-Nexis⁸ or Electric Library.⁹

European Report is available also in French as *Europolitique* and its publication is suspended during the month of August. Substantial discount rates for subscriptions are available for academic libraries as well as for Central and Eastern European subscribers.

Towards Enlargement exists only in English and its publication is suspended during the month of August. Substantial discount rates for subscriptions are available for academic libraries as well as for Central and Eastern European subscribers.

Printed every Thursday morning, *European Voice* has the exclusive co-operation of the European Commission, Council of Ministers and the European Parliament, who circulate 6,750 individually addressed copies of the newspaper to all Commissioners, their Cabinets, to MEPs and A grade civil servants. The rest of the total of 18.000 copies is composed of subscriptions to libraries, registered lobbyists, the business community and the press.

The full-text version of *European Voice* is available online¹⁰ on the day of publication by taking out an e-subscription which is an alternative to the printed one. Unfortunately, only few leading articles and table of content of the current issue are available on the Internet for free.

The indisputable advantage of *European Voice* is its weekly updated on-line archive which contains the articles from all of the issues since September 1995. The search option is free but the access to the full text is limited and depends on current subscription to the electronic version of the publication. A full list of all the issues along with the date and headline of the issue can be viewed using the browse options. Each article from the content of this database can be sent via an e-mail, the registered user can also join the mailing list and receive automatically by e-mail any article which contains a word matching one in the list of keywords created during the subscription (Hotlist service).
