Since the late 1980s, Karen K. Kemp has been working collaboratively with GIS scholars worldwide to define the domain of geographic information science. While completing her Ph.D. at the University of California, Santa Barbara, she was co-editor of the *NCGIA Core Curriculum in GIS*, a 1,000-page, three-volume document published in 1990, now translated into several languages, and distributed worldwide that defined the foundation of the field as it evolved into a widely taught university subject. Since that initial project, while working in various faculty and academic administrative positions in the United States and Europe, she has contributed to several other similar projects, most recently as co-editor of the *Geographic Information Science and Technology Body of Knowledge*. Recently retired from the position of Director of the International Masters in GIS Program at the University of Redlands in California, she is now an independent scholar on the Island of Hawai'i pursuing her interest in applying the theories and techniques of geographic information science to the integration of Hawaiian traditional knowledge and Western science.
